Dear Elkie Wills,

This request is being made subject to the California Public Records Act: Government Code §6250-6268. Under this statute you have 10 calendar days from the date of receipt of this request to respond as to whether you will release the records requested as detailed below.

Information Requested

1. Records of all animals impounded from January 1, 2009, to March 20, 2010.
I'm requesting that EACH animal record contain the following Shelter Buddy data fields:

Depending on the method of record keeping used and my lack of familiarity with the Shelter Buddy system, the information being sought may not be contained in the list of data field names above. Please review Attachment 1 for brief descriptions of each of the field names above to clarify what information is being requested and if the information described is contained in a differently named data field, please provide that information along with the correct data field name.

2. Euthanasia Data from January 1, 2009, to March 20, 2010.

For animals euthanized, include the following:

(Reference: Section 32003 of the California Food and Agricultural Code)

- a. Animal ID
- b. Date of Euthanasia
- c. Circumstances under which the animal was euthanized. Some examples of this data are: Euthanized in the field, at clinic or hospital, at Oceanside campus, at Gaines St. campus.
- d. Name or names of the personnel who euthanized the animal.
- e. Description of any medical treatment provided to the animal, and the name of the veterinarian of record.

Form of Information Requested

Please provide the requested information electronically as a tab-separated text file (preferred) or as a Microsoft Excel file (*.xls) and send to the email address or mailing address listed below.

Denial and Redaction

Should you choose to deny this request, as required by law, please indicate the exact reason for denial and the person and title of the person who made such decision.

Attachment 1 – Data fields requested from the Shelter Buddy software systems.

Depending on the method of record keeping used, the information being asked for may not carry the same naming convention as stated in the Records Request. The following chart is to help establish a clearer understanding of what is being requested.

| Data field: | Description of what is being requested: |
|------------------------------|---|
| Agency | Location of the shelter, whether Oceanside or San Diego. For the San Diego location, if there is differentiation between the Gaines St. campus and the Sherman St. campus in this field, please provide that data. (This differentiation may be more clearly in the “Current Location” data field.) |
| Animal ID | Unique identifier used to differentiate between animal records stored in a data base or record keeping system. |
| Name | The animal’s name if one was given. |
| Status | Animal’s current status. Some examples of values for this data are: Available for Adoption, Stray Hold, Hold in Vet Care, Under Vet Care, Awaiting Sort, Awaiting Transfer, Euthanized. |
| Current Location | Building and kennel number, where applicable for animals still at the facility. |
| Surrender Reason | For animals surrendered, what was the reason given for the surrender. |
| Date in Shelter | Intake date; date animal came into the facility. |
| Intake Type | How the animal came to be in the facility. Some examples of values for this data are: ACO Impound, Stray, Owner Surrender, Humane Officer Seized, Humane Officer Surrendered, Euthanasia Request, DOA., Transfer In (from another facility) |
| Available For Adoption Date | Calendar date calculated for when the animal would be available for adoption. |
| Overall Rating | Include this data for the Oceanside facility, and if used at the other facilities, include it for them as well. For the Oceanside location, some examples of values for this data are: Number-1, Number-2, Number-3, Number-4. |
| Type of Animal | Dog, puppy, cat, kitten, rabbit, Guinea pig, bird, reptile, etc. |
| Breed (primary) | The animal’s primary breed |
| Breed (secondary) | The animal’s secondary breed |
| Sex | Male, Female, Spayed, Neutered, Unknown |
| Age (years and months) | Years and Months. Please ensure these are not merged into one field (or column). |
| Final Outcome or Status Date | Date of the final disposition or final outcome for the animal (see below). |
| Final Outcome Type | Final disposition. Some examples of final outcome type are: Adopted, Adopted Altered, Redeemed, Reclaimed, Transfer Out, Escaped, Died, Lost, Dead on Arrival, Euthanasia. |

| Final Outcome Reason | This may be called the Final Outcome Sub-Type in some systems. Some examples of values for this data are: New Owner, Sick, Injured, or the specific reason for Euthanasia. |
| Transfer Out | Where animals have been transferred out to another shelter, humane society, rescue group or adoption partner, list the name of that organization. |
